

**Feelerz.com End User License Agreement (EULA)****Last Updated: December 2024**

These General Terms and Conditions (the "Agreement") constitute a legally binding agreement between you (you, your Organization) and Feelerz.com, a service provided by Feelerz b.v. regarding your use of the Feelerz.com platform, including its website, application, and related services (collectively, the "Service").

By accessing or using Feelerz.com, you agree to be bound by these terms and conditions. If you do not agree to these terms, you should not use the Service.

**1. License Grant**

- Harassing, abusing, or threatening other users.
